Sir,

This has reference to appeal dated 04-08-2014 filed by you against the decision of non-accreditation to Master of Business Administration (MBA) programme of your Institution.

2. The Appeal was considered by the Appellate Committee of NBA in its meeting. The recommendation of the Appellate Committee was considered by the concerned Committees constituted for the purpose in NBA. Based on the decision taken by it; the status of the program is given in the table below:

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Jansons School of Business, Karumathamapatti, Coimbatore-641 659, Tamil Nadu as a whole. **As such the Institute should nowhere along with its name including on its letter head etc., write that it is accredited by NBA because it is program accreditation and not institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name and level of the program accredited and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

4. The accreditation status of the above program is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited program as indicated in the table in paragraph 2, appears on the website and information bulletin of your College.

5. The accreditation status awarded to the program as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
